9:10 a.m. (9:00 a.m. Item on Agenda) PUBLIC HEARING

Chair Morrell makes time for a Public Hearing and approval of a Resolution of the Colusa County Planning Commission adopting a Categorical Exemption and approving Use Permit No.19-4-1 for the continued operation of a landscaping material supply facility (bark plant).

9:22 a.m. Chair Morrell opens the Public Hearing and calls for public comment.

Mr. Rominger distributes a letter dated July 10, 2019, to Commissioners. He states he owns acreage adjacent to Renewable Fiber and lists several concerns related to noise, dust, public safety, inspections, traffic, fire suppression, employee training and sanitation. (Handout on file in Board Clerk's Office)

Mr. Brown from Renewable Fiber states that they have a mobile water supply and will be installing additional water lines. He further states that his employees are all trained per OSHA standards.

Commissioner Parsons and Chair Morrell both state they have concerns about an adequate water supply, due to the spontaneous combustion that has occurred in the past. Commissioner Parsons inquires as to how often the piles are rotated and how often internal temperatures are checked.

Mr. Brown states that there is a log book, but their system could be improved. He further states that he checks the piles on an as-needed basis. He states that many of these issues were a result of being a new start-up company, but in the last year, many of their practices have been improved.

Mr. Georgenson, Counsel for the Hendersons, speaks to the property directly adjacent to Renewable Fiber. He states that the Hendersons have experienced damage to their orchards as a result of the dust created by Renewable Fiber, and have dealt with several other nuisances. He further states that Renewable Fiber has promised to implement mitigation measures, which have not been completed in a timely manner.

Mr. Georgenson states the Henderson's issues are as follows:

- Dust mitigation to protect crops
- Herbicide use on materials
- Potential damage to home, fields, crops, staff, and livestock
- Timeliness of County Enforcement
- Evidence of storage reduction
- Stack height
- Downspouts on equipment
- Sanitation issues
- Proper training of staff
- Comparisons to Sierra Pacific Bark Plant in Oroville, CA

The Henderson's request the Planning Commission consider the following:

- The plant ceases operations until conditions are met
- Regularly scheduled and frequent inspections
- Emulate Sierra Bark Plant practices
- Any chemicals used on materials must be food grade
- Have a sprinkler system and downspouts on equipment

Mr. Brown reiterates that many changes have occurred in the past 12 months. The telephone poles are on site and the barrier is ready for installation. He further states that they don't use herbicides on their products.

Ms. Henderson states that Mr. Brown does not follow through with what he says.

10:48 Chair Morrell calls for further public comment. Hearing no other public comment, Chair Morrell closes the Public Hearing.
