The Board of Supervisors of the County of Colusa, State of California meets in Regular Session this 18th day of June 2024 at the hour of 9:00 a.m. Present: Supervisors Janice A. Bell, J. Merced Corona, Daurice K. Smith, Kent S. Boes and Gary J. Evans.

Opening Prayer - Pledge of Allegiance

CALFIRE UPDATE

CalFire Unit Chief Marcucci gives an update on the Sites fire. He states the fire has spread south with the direction of the wind. He also gives an update on the various fires that started over Father's Day weekend. He states an Incident Management Team has been implemented to manage the Sites fire as well as the Point fire in Sonoma County. Chief Marcucci states CalFire is mindful of constituents and their land, feed and livestock. He informs the Board if any constituents have any issues, to let CalFire know so they can meet their needs.

Incident Commander Martin informs the Board he and his team took command over the Sites fire this morning at 10:00 a.m. He states numerous teams have been deployed to fight the numerous fires that have started over Father's Day weekend, using a number of resources, such as helicopters, and will continue to do so. He states the area has been under a red flag warning that was supposed to lift at 8:00 a.m. this morning but will continue to stay in effect due to the wind aiding in the spread of the fire. Incident Commander Martin states the number one priority is the safety of the citizens and firefighters. He informs the Board evacuation orders have been placed, and that CalFire has been working to meet the needs of those who have chosen not to evacuate. He states CalFire will start to livestream their briefings at 7:00 a.m. as well as in the evening hours for those who want to remain updated and become involved. He further states CalFire will be activating additional resources from out of state and the National Guard to use aerial assets and more resources as needed.

Assistant Sheriff Bradwell informs the Board the Sheriff's Office is assisting with CalFire and the community. He praises the amount of resources being used in working on the fire.

Ms. Kelly informs the Board a shelter at the VFW Hall is now available for those effected by the fire.

PERIOD OF PUBLIC COMMENT

Pastor McMullan informs the Board MACC has FEMA funding to ensure evacuating families as well as their animals are placed with shelter. He states the County has expanded its Farmer's Market, which will take place every Thursday from 4-7 p.m. He further states the Farmer's Market will have Market Match for EBT cards as well as providing a \$20.00 voucher through an emergency program with FEMA to help those in need as well bring more money for the farmers.

Ms. Hessong addresses the Board stating she sends prayer for those impacted by the Sites fire. She further expresses her concerns with county funding and elections fraud.

He states he has prepared a letter correcting a number of missed statements in the Public Hearing Notice and he will be sending out the letter this week. He further states, if the Board recollects there was a letter received in December 2022 from the California Municipal Finance Authority and as

a result of the Aynium bond issuance we received \$36,000.00, which was split between the Nickels Soil Lab, Friends of the Library and Friends of the Colusa Animal Shelter. He states he received another \$3,125.00 check which will be evenly distributed to the same three non-profit organizations. He states on June 20, 2024 at 6:00 p.m. at the American Legion Post in Maxwell there will be a workshop/community meeting to discuss the preparation of Community Plans for Maxwell and area surrounding the new Sites Reservoir.

Mr. Doherty thanks the Board and Mr. Plucker for the letter on the Cortina CSD matter.

Ms. Allen informs the Board she met with the four primary Air Pollution Control Officers last week to discuss the Sites Project and the formation of a unified plan that will be used moving forward. She states her department has been watching the smoke impact from the Sites fire and the smoke is currently traveling south, away from Colusa County. She further states she has been receiving numerous phone calls to see if Colusa County still possesses an Ag Pass Program, and assures we still do.
