## Behavioral Health Board

### Minutes

January 12, 2021 – 3:00 P.M.

- 1) Meeting was called to order at 3:15 p.m. by Robert Wilson, member, substituting for Dave Bishop, Chairman.

- 2) Establish Quorum

Those in attendance: Audrey Uhring, Jeannie Scroggins, Diane Bransford, Cindy Pilaczynski, Robert Wilson, Terry Rooney, Mayra Puga, Heather Bullis-Cruz, and Bonnie Briscoe. Not in attendance: Walter Osbourn, Dave Bishop and Gloria Alvarez. *Quorum not established.*

- 3) Public Comment

There were no members of the public who attended the teleconference and therefore no public comment.

- 4) Old Business

- 6) Approval of December 2020 Minutes

- 7) Program Integrity

Heather reports that there was not a lot of change in intakes in December compared to the previous month. We had 42 intakes in December. Heather said that she did an annual comparison and the number of intakes for 2020 followed the same pattern as 2019.

8) Quality Assurance

Jeannie stated that the State has postponed the Triennial audit. The State will tell us in early March what the new date will be for the audit.

Jeannie shared 2019 vs. 2020 comparative information on how many clients were seen and by what type of services they received. In summary, the number of clients went down in 2020 by 54 but the amount of services they received went up.

Mayra stated the State has extended the due date of the Cultural Competency Plan to March 1, 2021.

Mayra shared that she is trying to organize a Substance Use Culture training that will be provided by Sacramento County. She is waiting to hear back from them.

10) Director's Report

Terry reports that Jeannie has been promoted to Program Manager position left vacant when Donna Deabel retired in December.

Terry also reported that we lost two additional staff in December and that a new one will be beginning next week.

Robert said there has been talk about gearing up again, but no news to report as of yet.
