8. MHSA Update:

- a. Safe Haven Report: Members enjoyed decorating pumpkins on Halloween. An Art Contest will end with select art showcased in a Safe Haven 2023 calendar. A fence is scheduled to be built around the current dirt lot next to the parking lot. The lot will be landscaped in the future to allow for outdoor groups and activities.
- b. Bright Vista Report: Fall into Fun event on 10/28/2022 was a fun success with about 40 youth who participated. Feast with Friends is a "members only" event scheduled for 11/23/2022.

9. Director's Report:

- a. HR Update: Deputy Director, Ms. Uhring, resigned and has moved out of state. Ms. Piper, Clinical Program Manager, has also resigned. These two positions will not be immediately filled. The current focus is filling the vacant positions of our direct service providers. The department recently interviewed nine candidates to fill two Mental Health Specialist positions.
- b. CCBH held their employee appreciation day which included training, team building, and service awards. Supervisor Boes and Supervisor Carter both presented awards to employees ranging from 5-30 years of service.
- c. Open Access clinic began last month as the dept. has seen an increase in services from this new process. Tuesday and Thursday are "walk-in intake" days where new clients can receive an intake appointment for that day to begin services.

10. Program Integrity:

a. Ms. Bullis-Cruz shared her report. She mentioned that request in service timeliness has improved because of Open Access. Urgent wait time has also improved.

11. Quality Assurance:

a. Ms. Rojas shared her handout regarding counts of services. She noted an increase in SUD services.

12. PRA Report:

a. Ms. Houston reported no grievances since last month. She is currently working on setting up test calls, and coordinating for AB 2275.
