## 8. MHSA Update:

- a. Safe Haven Report: Ms. Puga stated Safe Haven is doing well and there have been many people attending. Safe Haven will be hosting a St. Patrick's Day event serving corned beef & cabbage and a variety of healthy snacks.
- b. Bright Vista Report: Ms. Puga reported Bright Vista is still closed due to maintenance. Our Bright Vista Peer Support Specialists, Pamela and Sharon, have been stationed at Safe Haven in the meantime. The Safe Haven members are enjoying the additional peer support.

## 9. Director's Report:

- a. Mr. Hobson reported he is working with Mrs. Armstrong and Mrs. Briscoe on a presentation for our Board of Supervisors on the topic of Prop 1 implications and reforms since 2022. There is so much coming at Behavioral Health at once. There are additional requirements and programming & funding unknowns. We don't know a price tag on certain areas, which means we can't forecast anything. Prop 1 passing will cause the state to take back a quarter of a million dollars from us.
- b. Mr. Hobson stated that the Adult Residential Facility might not be something we can afford due to an increase in healthcare workers salary to \$25/hour. This facility doesn't seem to pencil out. Mr. Hobson stated he has sought out direction from our Board of Supervisors. We wouldn't want to open the facility and have to relocate staff five years from now due to cost. The building has other possible uses such as access to medical care and behavioral health care. Mr. Hobson stated our local Public Health conducted an assessment and the results were that everything in Colusa centric. The Board of Supervisors supports the idea of the building being used for a county collaborative office so others have easier access instead of driving to Colusa for everything. Mr. Hobson stated each room has a door with access to outside. He will be working with our CAO, Wendy Tyler, and DHHS Director, Elizabeth Kelly, on this project.
  - i. Supervisor Corona stated we are in need of a Westside facility and it would be very beneficial.
  - ii. Mr. Wilson stated he supports this idea too.
