

## UPDATED PRESS RELEASE FOR IMMEDIATE RELEASE

Cristy Jayne Edwards, Colusa County Elections Official announces that the candidate filing period for the November 5, 2024 General Election will start July 15<sup>th</sup> 2024 and run through Friday August 9th. If an incumbent officeholder does not file, the filing deadline is extended to non-incumbents only until Wednesday August 14th. The extended deadline does not apply if there is no incumbent. The following is a list of the offices set for election for 4 year terms unless noted otherwise:

- Arbuckle-College City Fire Protection District Three seats
- The Arbuckle Public Utility District One seat
- Arbuckle Recreation and Park District Two seats
- Cortina Community Service District Two seats
- Pierce Joint Unified School District Three seats
- City of Colusa Four Council seats Three 4-year and one 2-year

- Colusa County Board of Education Trustee Area 1 & 2
- Colusa County Water District Three seats
- Colusa Unified School District Three seats
- Glenn- Colusa Fire Protection District has one seat up in Division 3.
- Maxwell Fire Protection District Three seats
- Maxwell Public Utility District –Three seats
- Maxwell Recreation and Park District Three 4-year and one 2-year
- Maxwell Unified School District Three 4-year seats and one 2-year
- Princeton Joint Unified School District Two seats
- Bear Valley Indian Valley Fire Protection District Three seats
- Stony Creek Joint Unified School District one 4- year term position up in Trustee Area 4 and a 2- year term up in Trustee Area 5.

In general, the qualifications for these offices require the candidate to be a registered voter of the district and applicable trustee area they are running for. There are no filing fees for any of these offices. Candidates have the option to publish a Candidate's Statement of Qualifications in the county voter guide at their expense.

Candidates for City offices, obtain and file nomination papers and other candidacy forms at City Hall. In order to qualify, candidates must obtain a minimum of 20, but no more than 30 signatures from properly registered voters within their cities.

Prospective candidates for all other offices obtain and file candidacy forms with the County Clerk-Recorder Registrar of Voters. The County Elections Office is located at 546 Jay Street, Suite 200, Colusa. Hours are 8:30 a.m. to 4:00\* p.m. Monday through Friday.
