

NOTICE OF ELECTION

NOTICE IS HEREBY GIVEN that a Special Election will be held in Colusa County on Tuesday, October 29, 2024 in accordance with the provisions of the election laws of the State of California for the purpose of electing a governing zone council for Zone 3 of the Sites Project.

Colusa County Flood Control and Water Conservation District creating the Sites Zone Council of 5 members at large for a term of 4 years, staggered per EC 10505. Candidates must be an eligible voter of the zone which they represent at the time of the election and during the entire term of office; and be a landowner participant in the Sites project designated to be managed by Zone 3, and if the zone council election is held before landowners are able to establish participation in the Sites project, the candidacy should be evidenced by owning land in the Zone 3 jurisdiction and showing the landowner was previously participating in the Sites project through a home district agreement.

Filing Period: Opens Monday July 8th and closes at 5:00p.m. Friday August 2th.

Declarations of Candidacy and filing forms will not be accepted after 5 p.m. on August 2, 2024, unless the incumbent does not file. In the event that the incumbent does not file, by the filing deadline, the filing period is extended 5 days to 5:00p.m. on August 14th for any qualified candidate other than the incumbent. There is no extension if there is no incumbent to be elected.

To file: The Declaration of Candidacy and other filing forms may be obtained at the Colusa County Clerk-Recorder Registrar/Elections Office beginning on July 8, 2024 and must be filed in that office by the deadline. The Elections Office is located at 546 Jay Street, Suite 200, Colusa. Candidates handbooks are available at the County Clerk's Office during normal business hours. Candidates can download and complete a few of the required forms at www.countyofcolusa.org/elections in advance. The posted forms do not represent all forms required to complete the filing process. There is no fee to file, however if applicable, the optional candidate statements of education and qualification must be submitted and paid for at the time of filing the declaration of candidacy. For additional information call the County Elections Office at 458-0500.

Notice is further given that this will be an all mail ballot election per Election Code 10502. All ballots cast in said election will be counted centrally at the Colusa County Elections Office, Clerk-Recorder Registrar of Voters, Hall of Records, 546 Jay Street, Suite 200, Colusa, CA 95932. The counting process is open to the public.

If only one person has been nominated or there are no nominees for the office(s) to be filled or in the case of members elected at large or by trustee areas, there are fewer than the number to be elected, and no petition is signed by 10% or 50 voters (whichever is the smaller number), an appointment will be made. The qualified person nominated shall be seated at the organizational meeting of the board, or, if an insufficient number is nominated, the governing board shall appoint as necessary per EC 10515 at a meeting prior to Election Day. Persons so appointed shall be seated at the organizational meeting as if they had been elected.
