Bonds-Yes Bonds-No"

NOTICE IS HEREBY FURTHER GIVEN The Registrar of Voters shall accept arguments for and against the measure by submitted them in writing to the Colusa County Clerk, Elections Department, 546 Jay St., Suite 200, Colusa, CA 95932. Arguments may be submitted by the district governing board, any member(s) of the board, voter eligible to vote on the measure, bona fide association of citizens, or any combination of such voters and associations may file a written argument for or against any school measure. Printed arguments submitted to voters shall be titled with "Argument in Favor of Measure B" or "Argument Against Measure B", with rebuttals titled with "Rebuttal to Argument in Favor of Measure B" or "Rebuttal to Argument Against Measure B" accordingly not later than Monday August 19th, 2024, which is hereby fixed as the final date on which Arguments For or Against the measure must be submitted to the Colusa County Election Department, as provided by law, for printing and distribution to the voters, pursuant to provisions of the California Elections Code. Arguments may not exceed 300 words in length. The arguments will be made available for public examination during business hours for a period of 10 calendar days ending Thursday August 29th, 2024.

Thursday August 29, 5:00p.m., is hereby fixed as the final date on which Rebuttal Arguments not to exceed 250 words in length must be filed with the Colusa County Clerk. The rebuttal arguments will be made available for public examination for 10 calendar days ending September 9th, 2024.

Arguments and Rebuttals must be accompanied by a statement as prescribed by 9600 of the Elections Code. The preprinted form is available on the Elections website under "forms" at www.countyofcolusa.org/elections or at the County Election Department.

Notice is further given that Arguments/Rebuttal arguments filed under the authority of the California Elections Code will be available for public examination in the Colusa Election Department for not less than 10 calendar days immediately following the date of the filing deadline.

There will be two vote centers for said election.
