### 8. MHSA Update:

- a. Safe Haven Report: Ms. Puga reported Safe Haven will be holding their summer barbeque on July 24<sup>th</sup>. Please spread the word, all staff and members are welcome. We will now be open Saturdays from 10:00am to 3:00pm.
- b. Bright Vista Report: Bright Vista has been slow. Summer time tends to slow down. We sent out mailers to all active members inviting them to attend.

### 9. Director's Report:

- a. Dr. Hobson stated we are approved by the State for mobile crisis. It was approved July 1<sup>st</sup>. We have had two mobile crisis responses in the week and a half.
- b. Dr. Hobson stated we can look at skipping one of the summer months for our meeting since many are out on vacation.
- c. Many of our contracts were approved in June. This is the start of the new fiscal year for us.
- d. Care court will be next on agenda, waiting for new local judge to be appointed.
- e. Beginning of January we will be applying for an extension for housing and Prop 1.

### 10. Program Integrity:

- a. Mrs. Bullis-Cruz reported per members request intakes for last quarter of year. Steadily going down, probably due to summertime and the heat. Urgent request are going up. We don't know what the reason for the wait days listed on this report. Mrs. Bullis-Cruz stated she will look in to it.
- b. Mr. Martinez stated in June we did not do intakes. Services and intakes dropped in June, wait days went up.

#### 11. Quality Assurance:

a. Mrs. Rojas is not present. Mr. Martinez reported the data for Mrs. Rojas. We did have a dip in services. Probably due to therapist being out for training in June. We did have a small dip in medication management.
