## COLUSA COUNTY FARM LABOR CONTRACTOR REGISTRATION

The Agricultural Commissioner wishes to emphasize the following items prior to registration. The Farm Labor Contractor's signature below signifies that these items have been reviewed with the Agricultural Commissioner's staff.

- 1. Every Farm Labor Contractor licensed in the State of California that intends to perform various functions and duties is required to:
  - a. Register with the Agricultural Commissioner of the county or counties in which the labor contractor has contracted with the grower;
  - b. Carry his or her license and proof of registration with him or her at all times;
  - c. File a current address with the Agricultural Commissioner of the county in which the farm labor contractor has contracted.
- 2. A civil penalty of not more than one thousand dollars (\$1,000) for each violation may be levied against a person for violating Section 1695 of the Labor Code, which pertains to registration and filing a change of address with the Agricultural Commissioner; or Division 7, Chapter 2, Article 10.5 of the California Food and Agricultural Code pertaining to Pesticide and Worker Safety.
- 3. The State of California requires the safety of employees that may enter a field when exposure to a pesticide or its residue can be reasonably expected.
- 4. Farm Labor Contractors and their supervisors shall be informed of the meaning of warning signs that are placed at the corners and entrances of fields that are treated with a pesticide.
  - a. The warning sign means that the field has been treated with a pesticide and that nobody is to enter the field without proper safety equipment.
- 5. Farm Labor Contractors and their supervisors shall be informed of activities prohibited during the reentry interval.
- 6. Farm Labor Contractors engaged in the application of pesticides, including bait, must be licensed as an Agricultural Pest Control Business and register with the Agricultural Commissioner as such.
