NOTICE OF PUBLIC HEARING APPLICATIONS FOR PROGRAM INCOME FUNDING

The County of Colusa will conduct a public hearing on November 14, 2024 at the Granzella's Inn Conference Center at 391 6th St, Williams, CA 95987 at 5:30 pm in order to discuss possible applications for funding using the State Community Development Block Grant (CDBG) Program Income Funds and to solicit public input on possible activities to be included in the application.

The County of Colusa is considering activities for Program Income funds available including General Administration Funds as follows:

CDBG Program Income up to

\$1,250,000

The County may program one or two years of funding through this application process; however, funds for each fiscal year will become available on July 1 of that fiscal year (e.g. July 1, 2025 and July 1, 2026).

Eligible activities consist of: Homeownership Assistance and Housing Rehabilitation Programs; Public Facility and Public Improvement Projects (Including Public Improvements in Support of New Housing Construction); Public Service Programs, Planning Studies, Economic Development Business Assistance and Microenterprise Activities. Eligible activities paid for with State CDBG funds must meet one or more of the three national objectives listed in CDBG federal statues as follows: Benefit to low-income households or persons; elimination of slums and blight; or meeting urgent community development need.

The purpose of this public hearing will be to give citizens an opportunity to make their comments known on the proposed application of Program Income project(s). The County is considering funding the rehabilitation and expenditures to support Karen's House, a non-profit organization that provides services to victims of domestic violence.

Any member of the public may attend this meeting in-person, participate in the meeting, and be heard on the item described in this notice; or members of the public may submit written comments prior to the meeting to Colusa County Community Development Department Community Block Grant Program, 1213 Market Street, Colusa, California 95932 or Greg Plucker at gplucker@countyofcolusa.com. Your comments will be read and addressed at the meeting and a written response will be provided.
