Jamie Sachs reports that they currently have 8 formal probation cases, 1 juvenile in boot camp, 1 in the juvenile hall serving a terminal sentence, 8 informal probation cases, and 1 deferred entry of judgement. Things are going very well with the new hall. They are trying to get more staff, but are having difficulty. They are seeing improvements with kids that were sentenced to boot camp verses kids sent to the juvenile hall. They are still involved

with the School Attendance Review Board (SARB) process. There is an oversight committee for all counties in California and their juvenile cases called The Office of Youth and Community Restoration (OYCR), which replaced The California Youth Authority (CYA).

#### Colusa Police Department

Josh Fitch reports they have been to the schools more due to fights.

#### Williams Police Department

Chris Miller reports they recently had 2 parole agents from Ventura County looking for a sex offender parolee that moved to the area. The agents provided no more information.

Jose Ruiz reports they are also involved with SARB.

#### Colusa County Behavioral Health

Tony Hobson reports they renewed their contract with the juvenile hall for mental health services.
