## Invasive Mussel Prevention Program

### Clean, Drain, Dry Self-Certification

Has your vessel been used in Sacramento, San Joaquin, Solano, Contra Costa, Alameda, Stanislaus, Merced, Fresno, San Benito, Kings, Kern, Ventura, Los Angeles, San Bernadino, Orange, Riverside, San Diego or Imperial counties?

Golden, Quagga, and Zebra Mussels Pose a Major Threat to  
EAST PARK RESERVOIR!

**Mussels in East Park can:**

- Encrust boats and clog engines.
- Foul facilities like docks and ramps.
- Litter beaches with sharp smelly shells
- Disrupt the food chain and fishing.

These invasive species from Eastern Europe, China, and Southeast Asia are spreading at a fast rate across the United States. They are transported to new areas attached to boats or harbored in tiny amounts of water.

**I affirm that my vessel trailer, and/or equipment is/are cleaned, drained, and dry prior to launching at East Park by attesting to one of the following.**

\_\_\_\_\_ Vessel not used in last 30 days in counties or waterbodies with Golden, Quagga, and/or Zebra infestations. If vessel has been used in any other waterbody outside of East Park, the vessel has been washed, drained, flushed, and allowed to completely dry for at least 5 days.

\_\_\_\_\_ If vessel has been used in a county or waterbody with Golden, Quagga, and/or Zebra infestations, it has been washed, drained, flushed, and allowed to completely dry for 30 days.

\_\_\_\_\_ Vessel professionally decontaminated at an approved Mussel Decontamination Station.
