
Fiscal Year 2025-26 Recommended Budget

Presented for your consideration is the Fiscal Year 2025-26 Recommended Budget. The total budget including the General Fund, special revenue funds, enterprise funds, internal service funds, county service areas, dependent special district, and other restricted funds is \$133,514,500*.


By approving the Recommended Budget, you are authorizing the expenditure of funds for operational needs until such time as the Final Budget is adopted. Due to the County's current fiscal climate, there are no fixed assets proposed for purchase prior to adoption of the Final Budget in September.

It should be noted that technical review is still underway and meetings between the departments and ad hoc committee have not taken place. I would caution everyone that the amounts reflected in this Recommended Budget are likely to change significantly for departments as we work toward the Final Budget.
