ELECTION DAY OBSERVERS - ELECTION OFFICE

Tuesday, Nov 4, 2025

The office opens at 7:00am and closes at 9:00 pm and when Secretary of State Office verifies our unofficial reporting results. Election Night Observers are welcome at any time at the Election Office. Initial results will be available after 8:00pm and will include vote by mail ballots that have been received and processed in the Elections Office. Results will continue to be updated until all precincts totals are reported. Hard copies of results will be available in the office as updated results become available. Unofficial results will also be posted to the Elections Office website at the end of the night. After 8:00 pm, the random 1% selection of precincts will be generated using a random draw. Elections office staff are required to stay until approval is received from the Secretary of State to leave for the night.

CANVAS

Thursday, November 6, 2025

The California Elections Code requires that the official canvass begin no later than the Thursday following the election, that it be open to the public, and that it continue daily (Saturdays, Sundays, and holidays excepted) for not less than six hours each day until completed. Canvass may begin prior to this date and time but must begin no later than Nov 6, 2025 10:00 am.

ONE PERCENT MANUAL TALLY EC 15360

Monday, Nov 10 daily until done from 9:00 am-12:00 pm & 2:00 pm-4:30 pm. A hand count of random precincts will be conducted of those precincts selected at random on Election Night. Additional precincts may be added.
