

RESOLUTION NO. 25-056

A RESOLUTION OF INTENTION OF THE COLUSA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT TO DETACH LAND FROM ZONE OF BENEFIT NUMBER 3

WHEREAS, on February 27, 2024, the Board of Directors of the Colusa County Flood Control and Water Conservation District ("District") adopted Resolution No. 24-07, forming Zone of Benefit No. 3 of the District;

WHEREAS, on April 24, 2025, the Kletsel Dehe Wintun Nation submitted a written request to the Sites Project Authority seeking removal of its lands and interests from the Zone 3 mapped area;

WHEREAS, on September 3, 2025, the Zone of Benefit No. 3 Council formally requested that the District initiate proceedings to detach the Kletsel Dehe Wintun Nation lands from Zone of Benefit No. 3;

WHEREAS, pursuant to the authority contained in the California Water Code Appendix, Chapter 123-601 et seq., the Board of Directors of the District may alter the boundaries of a Zone of Benefit following notice and hearing as required by law; and

WHEREAS, it is the intent of the District to detach land from Zone of Benefit Number 3 and approve the revised jurisdictional boundaries of which are defined in the map attached hereto as Attachment "A."

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Colusa County Flood Control and Water Conservation District that on November 18, 2025, at the hour of 9:30 a.m., in the Board of Supervisors Chambers of the Colusa County Courthouse, 547 Market Street, Colusa, California, a public hearing shall be held to consider the proposed detachment of the lands of the Kletsel Dehe Wintun Nation from Zone of Benefit No. 3. Any formal protest must be made in writing and submitted at the hearing. Protest forms will be made available at the hearing.

BE IT FURTHER RESOLVED, that a copy of this Resolution of Intention to Detach Land from Zone of Benefit No. 3 shall be published in the Pioneer Review, a newspaper of general circulation, pursuant to Government Code Section 6066, with the first publication to be at least 14 days prior to the date fixed for the public hearing.
