BOARD OF SUPERVISORS COUNTY OF COLUSA, CALIFORNIA

A RESOLUTION ESTABLISHING THE ALMOND PARADISE STREET LIGHTING BENEFIT ASSESSMENT AREA AND SETTING THE ANNUAL ASSESSMENT FOR THE 1984-85 FISCAL YEAR,

WHEREAS, Petition having been made to the Board of Supervisors of Colusa County for the establishment of a Special Street Lighting Benefit Assessment and creation of a Benefit Assessment Area, pursuant to the provisions of Section 54715, et seq. of the Government Code of the State of California, and

WHEREAS, all notices have been given as required by law, and

WHEREAS, Public Hearing has been held showing the necessity and propriety of the establishment of a Benefit Assessment and creating of a Benefit Assessment area, and

WHEREAS, the matter of establishing the amount of the assessment for the first year must be submitted to the eligible voters within the jurisdiction of the assessment area,

NOW, THEREFORE, IT IS RESOLVED AND ORDERED BY THIS BOARD OF SUPERVISORS OF THE COUNTY OF COLUSA, at a regular meeting thereof held on ________, 1984, as follows:

1. The BOARD OF SUPERVISORS of the County of Colusa hereby orders the creation of the ALMOND PARADISE STREET LIGHTING BENEFIT ASSESSMENT AREA pursuant to the provisions of Section

- 54715 (b) of the Government Code of the State of California.
- 2. The area included within the Benefit Assessment Area shall be all that area as included on the ALMOND PARADISE SUBDIVI-SION MAP recorded with the County of Colusa on May 31, 1979, in Subdivision Book 1 Page 20 and specifically including each assessors parcel as listed on Exhibit "A" attached hereto and incorporated herein by reference as though set forth in full herein.
- 3. This Benefit Assessment is established for the sole and exclusive purpose of providing street lighting within the defined area.
- 4. The parcels included in the above defined area shall be assessed an amount equal to the cost of maintaining said street lighting and such assessment shall be allocated equally among all such parcels within the area. For the 1984-85 Fiscal Year the assessment shall be the sum of \$ 32.00 per parcel for each separately identified assessors parcel located within the Benefit Assessment Area.
- 5. The BOARD OF SUPERVISORS of Colusa County shall be the Governing Board of said Area.
- 6. A special election to approve the annual assessment for the 1984-85 Fiscal Year for the ALMOND PARADISE STREET LIGHTING BENEFIT ASSESSMENT AREA is ordered to be held on Tuesday, June 5, 1984, and shall be consolidated with the Primary election to be held in the State of California on Tuesday, June 5, 1984.
- 7. At said special election, the question to be presented to the qualified voters of the area shall be:

"SHALL THE ANNUAL ASSESSMENT FOR STREET LIGHTING PURPOSES WITHIN THE ALMOND PARADISE BENEFIT ASSESSMENT AREA FOR THE 1984-85 FISCAL YEAR BE ESTABLISHED AT THE RATE OF \$32.00 PER YEAR FOR EACH SEPARATELY IDENTIFIED ASSESSORS PARCEL LOCATED WITHIN THE BENEFIT ASSESSMENT AREA?"

- 8. The election shall be conducted by the County Clerk of the County of Colusa in all respects in conformity with the laws regulating the conduct of general elections and in conformity with all applicable provisions of the Election Code of California.
- 9. The proponents, REYNEN and BARDIS, shall reimburse the County of Colusa in full for the services performed by the County Clerk of the County of Colusa upon presentation of a bill for such services.
